Mayor Pro Tem Griffin made the following public announcement asking all individuals to be cognizant of the two signs at the entrance to the Council Chamber room referencing Sections 30.06 and 30.07 of the *Penal Code*, *persons licensed under Subchapter H, Chapter 411, Government Code may not enter this property with a concealed handgun nor enter this property with a handgun that is carried openly.*

3. Christopher "Jay" Horton, 105 Brookwood, Ovilla: voiced concerns of inadequate drainage, citywide damage and the need to clean the city culverts from the heavy rainfall.
4. Del Urbanczyk, 101 Oakwood, Ovilla: asked for assistance with the flood damage to his home and yard that occurred during the recent storms.
5. Four others signed up to speak on Item 3.

**PUBLIC HEARING** – Receive public comment on Ordinance 2018-22, amending the Land Use Table of Article 2, Section 11.3 of the Ovilla Comprehensive Zoning Ordinance, No. 2010.013 as amended; providing for a winery in specified areas and removing the specified uses for a Dwelling Guesthouse; amending Article 6, Section 53.1 “General Definitions” of the Comprehensive Zoning Ordinance NO. 2010.013 as amended; providing a definition of “Winery”; providing a savings clause, providing a severability clause; providing an effective date; and providing for publication.

- **Staff Presentation** – was presented by City Manager John Dean and Code Officer Mike Dooly.
- **Public Comment** - Mayor Pro Tem Griffin opened the Public Hearing at 6:56 p.m., to receive comments. There were no comments in favor or in opposition. Mayor Pro Tem Griffin closed the Public Hearing at 6:57 pm.
- **Council deliberation** – The Planning and Zoning Commission forwarded recommendation for approval.

PH - ITEM 1. **DISCUSSION/ACTION** – Receive recommendation report from the Planning and Zoning Commission to consider and take action on Case No. PZ18.09, Ordinance 2018-22 of the City of Ovilla, Texas, amending the Land Use Table of Article 2, Section 11.3 of the Ovilla Comprehensive Zoning Ordinance No. 2010.013 as amended; providing for a winery in specified areas and removing the specified uses for a Dwelling Guesthouse; amending Article 6, Section 53.1 “General Definitions” of the Comprehensive Zoning Ordinance No. 2010.013, as amended; providing a definition of “Winery”; providing a savings clause, providing a severability clause; providing an effective date; and providing for publication.

PL4 Hunt moved that the Ovilla City Council approve Ordinance 2018-22 of the City of Ovilla, Texas, amending the Land Use Table of Article 2, Section 11.3 of the Ovilla Comprehensive Zoning Ordinance No. 2010.013 as amended, providing for a winery in specified areas and removing the specified uses for a Dwelling Guesthouse; amending Article 6, Section 53.1 “General Definitions” of the Comprehensive Zoning Ordinance No. 2010.013, as amended; providing a definition of “Winery”; providing a savings clause, providing a severability clause; providing an effective date (immediately); and providing for publication, seconded by PL2 Oberg.

No oppositions, no abstentions.

**VOTE: The motion to approve carried unanimously: 5-0.**

**PUBLIC HEARING** – Receive public comment on a code violation abatement, “Nuisance Outside Storage”, Section 8.02 of the Ovilla Code of Ordinances at the property designated as Lot 9, Block 2, Brookwood #2, Ovilla, Ellis County, Texas 75154, more commonly known as 101 Oakwood.

- **Staff Presentation** – presented by Code Enforcement Officer Mike Dooly. New photos taken this date were shared. Multiple complaints had been made on the condition of this property.
- Mr. Urbanczyk/owner of said property was present, shared a letter he typed, asking for additional time to clean up the outside of his property.
- **Council deliberation** – Council questioned inconsistencies with Mr. Urbanczyk’s comments and believed that he had been given ample time. Their recommendation was to check the property in 10-12-days, hoping it was cleaned up by October 22. State law allows 30-days before moving forward with the abatement process.

PH - ITEM 2. **DISCUSSION/ACTION** – Consideration of and action on a code violation abatement, “Nuisance Outside Storage”, Section 8.02 of the Ovilla Code of Ordinances, at the property designated as Lot 9, Block 2, Brookwood #2, Ovilla, Ellis County, Texas 75154, more commonly known as 101 Oakwood.

PL4 Hunt moved that Council approve the abatement and direct staff to move forward with the code violation abatement, "Nuisance Outside Storage", Section 8.02 of the Ovilla Code of Ordinances, at the property designated as Lot 9, Block 2, Brookwood #2, Ovilla, Ellis County, Texas 75154, more commonly known as 101 Oakwood, seconded by PL1 Huber.

*No oppositions, no abstentions.*

*VOTE: The motion to approve carried unanimously: 5-0.*

**REGULAR AGENDA**

**ITEM 1. DISCUSSION/ACTION** – Consideration of and action on a revised Site Plan Application submitted by Pamilee Koval, as authorized by Thomas Waits, to add a free-standing canopy, located at 713 W. Main Street, Ovilla, TX 75154.

Staff reported that the applicant had added a detached canopy next to the existing framed-storage building, which was previously permitted to sell snow-cones. In August 2018, applicant submitted a (Specific Use Permit) SUP application with Site Plan documents and was directed by Council to revise the existing structure which was erected prior to acquiring a permit. Applicant submitted new documents that included a photo illustrating revisions made to the existing canopy. Council stressed the importance of acquiring a permit prior to construction.

PL2 Oberg moved to approve the revised Site Plan Application submitted by Pamilee Koval, as authorized by (owner) Thomas Waits, to add a free-standing canopy, located at 713 W. Main Street, Ovilla, TX 75154, authorizing the city manager to approve a building permit, seconded by PL1 Huber.

*No oppositions, no abstentions.*

*VOTE: The motion to approve carried unanimously: 5-0.*

**ITEM 2. DISCUSSION/ACTION** – Consideration of and action on Ordinance 2018-23 of the City of Ovilla, Texas amending Chapter 1, Section 1.02.002 of the Code of Ordinances declaring an official city newspaper and declaring an effective date.

Staff reported that pursuant Chapter 1, Article 1, Section 1.02.002 of the Ovilla Code of Ordinances and Section 52.004 of the Local Government Code, the municipality shall declare an official newspaper annually for city required publications. The Ellis County Press is the city's current newspaper on file. They publish once-weekly. The Waxahachie Daily Light publishes three-times weekly.

PL2 Oberg moved that Council approve Ordinance 2018-23 of the City of Ovilla, Texas amending Chapter 1, Section 1.02.002 of the Code of Ordinances declaring the Waxahachie Daily Light as the official city newspaper effective immediately, seconded by PL1 Huber.

*No oppositions, no abstentions.*

*VOTE: The motion to approve carried unanimously: 5-0.*

**ITEM 3. DISCUSSION/ACTION** – Consideration of and action on Ordinance 2018-24 of the City of Ovilla, Texas, regulating the operation of golf carts on public streets; providing for a penalty for the violation of this ordinance; providing for repealing, savings and severability clauses; providing for an effective date of this ordinance; and providing for publication.

This Item was presented as a discussion only item during the regular September City Council meeting. Staff was directed to address certain questions with legal counsel and returned with additional information:

1. Can Council set an age limit different from state law – No
2. Can Council require seatbelts – No
3. Require insurance - Yes

Staff was directed to return with this item for Council consideration. Information from other cities, as well as recommendations from the Police Chief and City Attorney were considered when preparing the ordinance. Staff reported that they believed the presented ordinance met the desires of many Ovilla residents, allowing the use of golf carts on certain city streets. The presented ordinance does not allow golf carts on any of the major thoroughfares identified in the thoroughfare plan as well as Bryson Lane, East Highland Road and Water Street. Golf cart owners will be required to apply for and pay for a permit, including an inspection from the police department.

Mayor Pro Tem Griffin allowed those that signed up to speak on this item:

1. Chrystyna Reymann, 505 Edgewood Lane – in favor of the ordinance
2. Ainsley Jarvis, 503 Edgewood Lane – In favor of the ordinance (set restrictions for night use)
3. Mike Bira, 100 Hummingbird Lane – In favor of the ordinance (electric golf carts only)
4. Perry Kaemmerling, 907 Slippery Elm Drive – In favor of the ordinance (allow use on more streets)
5. Roger Stevenson, 200 Brookwood Court – In favor of the ordinance
6. Peter Harding, 905 Slippery Elm – In favor of the ordinance

Council opinions were divided as there were concerns about safety.

PL4 Hunt moved to deny Ordinance 2018-24 of the City of Ovilla, Texas, regulating the operation of golf carts on public streets; providing for a penalty for the violation of this ordinance; providing for repealing, savings and severability clauses; providing for an effective date of this ordinance; and providing for publication, seconded by PL1 Huber.

*Three Council Members, PL2 Oberg, PL3 Griffin and PL5 Myers voted in opposition, no abstentions.*

**VOTE: The motion to deny the ordinance failed.**

Another motion was made.

PL5 Myers moved to approve Ordinance 2018-24 of the City of Ovilla, Texas, regulating the operation of golf carts on public streets; providing for a penalty for the violation of this ordinance; providing for repealing, savings and severability clauses; providing for an effective date of December 01, 2018 for this ordinance; and providing for publication, seconded by PL2 Oberg.

*Two Council Members, PL4 Hunt and PL1 Huber voted in opposition, no abstentions.*

**VOTE: The motion to approve Ordinance 2018-24 carried with a 3-2 vote.**

**ITEM 4. DISCUSSION/ACTION** – Consideration of and action on Ordinance 2018-25 of the City of Ovilla, Texas, amending Chapter 3, Article 3.06, Section 3.06.002, 3.06.005 and 3.06.007(5) of the Code of Ordinances of the City of Ovilla; establishing definitions for signs; amending the schedule for temporary signs; amending the prohibited signs; providing a savings clause; providing a severance clause; providing for incorporation into the Ovilla Code of Ordinances; providing for immediate effect; and providing for publication.

During the September Council meeting, staff was directed to return with an updated sign ordinance. The changes to the sign ordinance provide definitions for feather banner signs, allowing one feather banner sign per premise, and defines and allows an A-frame or sandwich board sign as a temporary sign, and clarifies the Code regarding signs placed on vehicles. The Ordinance was reviewed by the City Attorney.

PL4 Hunt moved to approve Ordinance 2018-25 of the City of Ovilla, Texas, amending Chapter 3, Article 3.06, Section 3.06.002, 3.06.005 and 3.06.007(5) of the Code of Ordinances of the City of Ovilla; establishing definitions for signs; amending the schedule for temporary signs; amending the prohibited signs; providing a savings clause; providing a severance clause; providing for incorporation

into the Ovilla Code of Ordinances; providing for immediate effect; and providing for publication, seconded by PL2 Oberg.

*No oppositions, no abstentions.*

*VOTE: The motion to approve carried unanimously: 5-0.*

**ITEM 5. DISCUSSION/ACTION** – Consideration of and action on Ordinance 2018-26 of the City of Ovilla, Texas, amending the Fiscal Year 2018-2019 General Fund Budget of the City of Ovilla to allow for an adjustment of \$260,000 for the purchase of real properties being identified as Ellis CAD Property ID's 187744, 187748, and 187741; providing for publication of this Ordinance and providing an effective date.

The City Council recently adopted Resolutions authorizing the purchase of the properties identified above at a cost of \$255,000. Staff asked for an amendment of \$260,000.00 to ensure that funds were available to cover any additional costs that may be associated with the property purchases.

PL2 Oberg moved that Council approve Ordinance 2018-26 of the City of Ovilla, Texas, amending the Fiscal Year 2018-2019 General Fund Budget of the City of Ovilla to allow for an adjustment of \$260,000 for the purchase of real properties being identified as Ellis CAD Property ID's 187744, 187748, and 187741; providing for publication of this Ordinance, effective immediately, seconded by PL1 Huber.

*No oppositions, no abstentions.*

*VOTE: The motion to approve carried unanimously: 5-0.*

**ITEM 6. DISCUSSION/ACTION** – Consideration of and action on Ordinance 2018-27 of the City of Ovilla, Texas, amending Chapter 8, "Offenses and Nuisances," Article 8.01 "General Provisions," of the Code of Ordinances of the City of Ovilla, Texas, prohibiting the sale of alcoholic beverages within certain distances of churches, schools, and hospitals.

The presented ordinance was prepared by the City Attorney for the City Council to be able to consider, if the Council so desires, to regulate future alcohol sales within certain limitations as allowed by state law. This basically allows a public or private school governing body to request that the City Council adopt an ordinance prohibiting alcohol sales within 1,000 feet of the school. Initial discussion and the proposed ordinance were presented to Council during the September meeting. Staff was directed to bring the Ordinance back for consideration.

PL5 Myers moved to approve Ordinance 2018-27 of the City of Ovilla, Texas, amending Chapter 8, "Offenses and Nuisances," Article 8.01 "General Provisions," of the Code of Ordinances of the City of Ovilla, Texas, prohibiting the sale of alcoholic beverages within certain distances of churches, schools, and hospitals, seconded by PL4 Hunt.

*No oppositions, no abstentions.*

*VOTE: The motion to approve carried unanimously: 5-0.*

**ITEM 7. DISCUSSION/ACTION** – Consideration of and action on Ordinance 2018-28 of the City of Ovilla, Texas, amending Appendix A, Article A7.000, Section A7.001 of the Code of Ordinances of the City of Ovilla; establishing monthly rates for solid waste collection for residential and non-residential customers; providing a savings clause; providing a severance clause; providing for incorporation in the Ovilla Code of Ordinances; providing for immediate effect; and providing for publication.

Staff presented an ordinance with new proposed rates in accordance with changes associated with the City's new service contract with Community Waste Disposal (CWD). New rates will take affect with

the December 2018 usage billing. The new residential rates are established to generate the same amount of revenue for the City as the current rate structure.

PL4 Hunt moved to approve Ordinance 2018-28 of the City of Ovilla, Texas, amending Appendix A, Article A7.000, Section A7.001 of the Code of Ordinances of the City of Ovilla; establishing monthly rates for solid waste collection for residential and nonresidential customers; providing a savings clause; providing a severance clause; providing for incorporation in the Ovilla Code of Ordinances; providing for immediate effect; and providing for publication, seconded by PL5 Myers.

*No oppositions, no abstentions.*

*VOTE: The motion to approve carried unanimously: 5-0.*

**ITEM 8. DISCUSSION/ACTION-** Consideration of and action on Ordinance 2018-29 of the City of Ovilla, Texas, amending Appendix A, Article A7.000, Section A7.003 (B)(1) and A7.003 (B)(2)(B) of the Code of Ordinances of the City of Ovilla; establishing a monthly wastewater rate for residential and nonresidential customers; providing a savings clause; providing a severance clause; providing for incorporation into the Ovilla Code of Ordinances; providing for an effective date; and providing for publication.

The proposed rate increase of \$2.05 per 1,000 gallons is a direct cost increase incurred by the City from the service provider. As was discussed during the budget process all rate increases would be passed onto the customer.

Current Rate: \$8.22 per 1,000      Proposed Rate: \$10.27 per 1,000

PL2 Oberg moved to approve Ordinance 2018-29 of the City of Ovilla, Texas, amending Appendix A, Article A7.000, Section A7.003 (B)(1) and A7.003 (B)(2)(B) of the Code of Ordinances of the City of Ovilla; establishing a monthly wastewater rate for residential and nonresidential customers; providing a savings clause; providing a severance clause; providing for incorporation into the Ovilla Code of Ordinances; providing for an effective date (immediately); and providing for publication, seconded by PL5 Myers.

*No oppositions, no abstentions.*

*VOTE: The motion to approve carried unanimously: 5-0.*

**ITEM 9. DISCUSSION/ACTION –** Consideration of and action on staff direction for the use of AT&T Lease Funds.

Staff offered suggestions for use of the funds received from the AT&T Agreement (\$550,000):

1. Pay for the property purchase on Main Street.
2. Upgrade and prepare the Main Street property for Public Works use.
3. Bridge repairs.

Council had also addressed using some of the funds to pay debt.

Mayor Dormier requested to use the designated "Mayor" parking space for another purpose or allow others to use that parking space.

PL2 Oberg moved that Council approve to re-designate and/or un-designate the parking space currently designated for the Mayor, seconded by PL4 Hunt.
